RELATING TO PLANNING AND DEVELOPMENT SERVICES, DEPARTMENT OF TRANSPORTATION AND MOBILITY AND TUCSON FIRE; AMENDING RESOLUTION 23712 - APPROVING THE PUBLICATION OF A NOTICE OF INTENTION TO INCREASE RATES AND FEES – BY APPROVING AND INCORPORATING REVISED PDSD FEES; SCHEDULING A NEW PUBLIC HEARING FOR ALL FEES; AND DECLARING AN EMERGENCY.
