



BICYCLE LOCKER RENTAL AGREEMENT

Thank you for your interest in renting a bicycle locker from the City of Tucson. Bicycle lockers are available for annual rental at City Hall (255 W. Alameda St.), the City-State Garage (498 W. Congress St.), Library Garage (45 W. Alameda St.), La Entrada/Tucson Water Garage (310 W. Alameda St.), and at the Public Works Garage (50 W. Alameda St.). Please check with Park Tucson (520) 791-5071 for locker availability.

- Once you have selected the locker location and learned that the location is available, visit the Park Tucson office, 110 E. Pennington St., Suite 150. Fill out this *Bicycle Locker Rental Agreement* and pay the annual and refundable deposit fees. All information provided to the Park Tucson office will remain confidential.
- The locker rental fee is of \$24 per year, and a \$30 refundable deposit will be collected. These funds will be paid in advance. No pro-rated refunds will be given after six months.
- ➤ The terms of this rental agreement shall commence upon Park Tucson's receipt of payment and the signed Rental Agreement. Park Tucson will then issue a lock and key and the initial term of the agreement is for one year.
- ➤ City of Tucson employees may choose to pay for bike locker rental through the City's payroll deduction program. City employees are charged \$2 per pay period through the payroll deduction. At initial signup, the \$30 refundable deposit will be expected.

Terms and Conditions

This agreement entitles the renter to store one bicycle and related bicycle equipment, such as helmet, gloves, air pump, or lock, in the designated locker for the designated time period.

This agreement prohibits the use of the designated locker for storage of non-bicycle related equipment or material. If items other than those noted previously are stored in the locker, this agreement will be terminated immediately. Upon such termination, the City of Tucson, Park Tucson has the right to empty the locker of any property stored within.

As a condition for renting this locker, Renter waives any claim to the right to privacy and expressly consents to allow Park Tucson to open and inspect the locker and the contents thereof with or without notice. Entry and inspection may take place for the following reasons: (1) in an emergency; (2) to determine whether a health or safety hazard exits; (3) to determine any term of this Agreement is being violated; (4) to maintain the locker, its door or unlocking mechanism; (5) to sweep; or clean inside the locker.

Upon termination of agreement, the renter is responsible for removing the contents of the locker and returning the lock and key to Park Tucson. Park Tucson will inspect locker prior to refunding the deposit. If renter fails to remove their property from the locker it will be disposed of.

Renter may not make any alterations to the locker or damage it in any way. Renter may not sublease the locker, or transfer this Rental Agreement to any other person.

All personal property is stored by Renter at Renter's sole risk. The City of Tucson, Park Tucson, hereby disclaims any implied or express warranties, guarantees or representations of the nature, condition, safety or security of the locker and the station surrounding it. Renter hereby acknowledges and agrees that the City of Tucson, Park Tucson does not represent or guarantee the safety or security of the lockers, of any personal property stored inside, or of the stations themselves.

In the event that you are denied access to your bike locker due to an unforeseeable event, please contact the Park Tucson office as soon as possible (520) 791-5071. Pending resolution of the problem, Park Tucson may instruct you to store the bicycle at the nearest available Park Tucson bicycle rental facility.
