Item 5: Signal Phase and Timing (SPaT) Challenge: Sun Link Streetcar Presentation

<u>Issue</u> – Staff from TDOT Engineering will provide an overview of the SPaT Challenge and its implications for the Sun Link Streetcar.

Staff Recommendation – None at this time.

<u>Background</u> – The SPaT Challenge is a challenge to state and local public sector transportation infrastructure owners and operators to cooperate to achieve deployment of dedicated short-range communications (DSRC) infrastructure with SPaT broadcasts in at least one corridor or network (approximately 20 signalized intersections) in each of the 50 states by January 2020.

The Challenge is organized through the National Operations Center of Excellence (NOCoE), a partnership of the American Association of State Highway and Transportation Officials (AASHTO), the Institute of Transportation Engineers (ITE), and the Intelligent Transportation Society of America (ITSA) with support from the Federal Highway Administration (FHWA).

<u>Present Consideration</u> – Staff from the TDOT Engineering will present information on the SpaT Challenge for comment and discussion by members.

Item 6: Draft Complete Streets Design Guidelines

<u>Issue</u> – Staff will be presenting on the Draft Complete Streets Design Guidelines.

<u>Staff Recommendation</u> – None at this time.

<u>Background</u> – The Draft Complete Streets Design Guidelines (Guide) take the concepts described in the Complete Street Policy, passed by Mayor and Council in February 2019, and apply them to specific contexts and elements of city street design. The Guide, in combination with the Policy, institutionalizes the Complete Streets approach within City agencies to make it a routine part of the decision-making process.

The Guide provides direction to policymakers, City agencies, private-sector engineering firms, developers, and community members about where, when, and how to incorporate best practices in Complete Streets design. The Guide promotes higher-quality street designs that will ultimately, as each project is completed, result in a network of roadways stretching across the city that is safe, attractive, comfortable, and welcoming for all.

The Guide supplements but does not replace existing City of Tucson engineering practices to meet the goals of the Complete Streets Policy. It is general in application—providing design guidance on the preferred use of the right-of-way in a way that is consistent with tenets of Complete Streets—without being overly prescriptive.

<u>Present Consideration</u> – Staff will provide information on the draft Complete Streets Policy for review, discussion, and comment.

February 3, 2020: Revenue budget due to City Budget Office

February 3, 2020: Expense budget due to City Budget Office

April 21, 2020: Recommended budget submitted to Mayor and Council

June 9, 2020: Final budget adoption by Mayor and Council
