RNA Review Action Taken

Staff introduced the project and the applicant presented. The applicant provided the following clarifications in response to DRB questions:

- a) The roof over the existing patio will remain as it is; the proposed patio extension will be located under the existing parking garage above;
- b) The gate between the existing patio and the proposed addition will be removed;

- c) The proposed fence will leave 6 feet clearance for pedestrians between the patio and columns supporting the parking garage, and 10'6" between the patio and the curb;
- d) There is an existing gate on the patio; handles to the gate will be added for use as an emergency exit; and
- e) Proposed black color will be changed to match the existing patio's color.

Motion was made by DRB Member Clement to recommend to the PDSD director approval, finding the project in compliance with the Design Standards set forth in UDC Sections 5.12.7.C 1-15 and 5.12.7.D, subject to the following conditions: 1) The gate between the existing patio and the proposed addition along the north side of the patio is removed from site plans, as intended by the applicant; and 2) The black color of the proposed fence is to be revised to match the color of the existing fence. The motion was duly seconded by DRB Member Schau. Motion passed by a voice vote of 3-0. Motion passed unanimously.

5. Staff Announcements Informational

There are no formal submissions for DRB review at this time. There are currently no updates on the multi-family housing project at Congress and the I-10. DRB member Clement has kindly volunteered and has been authorized by the Mayor and Council to serve for another 4-year term in the DRB.
